OVERVIEW:

The Cuyahoga County Public Defender's Office seeks a positive, organized, flexible, thoughtful and dedicated Parent Advocate (PA) to join our interdisciplinary team to assist, mentor, advocate for families with Children and Family Services (CFS) involvement in our Pre-Petition Pilot Program Grant Funded Project called FIRST. Parent Advocates collaborate with social workers and lawyers as part of an interdisciplinary team representing the parent. The PA advocates for and with the client both inside courtrooms, and with service providers, CFS and other stakeholders in the child welfare system.

This is a grant funded position renewable up to the life of the grant, or until other funding can be secured.

RESPONSIBILITIES:

- ✓ Attending CFS staffings, Family Team Meetings and Semi-Annual Reviews with and as an advocate of the client
- ✓ Engaging and assessing client needs
- ✓ Maintaining regular communication with the client
- ✓ Supporting client engagement with relevant programs as required by their case plans (substance abuse, anger management, domestic violence, parenting, mental health services or other services as needed)
- ✓ Accompanying clients to appointments throughout the community to ensure seamless access to services.
- ✓ Working collaborative with clients, lawyers, social workers and other advocates
- ✓ Conducting home and program visits including those between client and child as necessary
- ✓ Advocating for client within the team and to other stakeholders
- ✓ Attending court hearings as needed
- ✓ Participating in community events and meetings related to the work of the Cuyahoga County Public Defender or any other assignments given by the Public Defender's Office.

QUALIFICATIONS

- Any of one of the following levels of education and experience will suffice
- Two years of case management /advocacy experience OR
- One year practical experience and an Associate's Degree
- Personal and/or professional experience with Children and Family Services strongly preferred
- Ability to work well independently and collaboratively with lawyers, non-lawyers, and court and agency staff
- Experience working in and with racially and socioeconomically marginalized communities
- Commitment to social justice and defending the rights of parents charged with abuse, neglect or dependency
- Demonstrated understanding of the issues of race and poverty as they relate to parents' experiences in the system
- Excellent interpersonal and communication skills
- Knowledge of Cuyahoga County community based resources
